ORDINANCE NO. 18-1

AN ORDINANCE DESIGNATING ALL-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF ALL-TERRAIN VEHICLES

The Town Board of the Town of North Bend, State of Wisconsin, does ordain as follows:

Section One: PURPOSE. This ordinance codifies permission by the Town Board of the Town of North Bend, for the operation of all-terrain vehicles (ATV) upon the roadways set forth herein, following due consideration by the board of the recreational value of so doing, weighted against the possible danger, public health, and liability aspects of this action. In so considering, the board has considered the terrain involved, traffic density, and history of use.

SECTION TWO: AUTHORITY. This ordinance is enacted pursuant to the town's powers under section 23.33 of the Wisconsin Statutes or its successor if amended. The provisions of section 23.33 of the Wisconsin Statutes are hereby incorporated and made a part hereof by reference.

SECTION THREE: ROUTES. The board designates the following routes in the

Town of North Bend as ATV routes:
From north side of Lockington Road to
Highway VV to Hall Road to Riverbend Golf Course—
and from Hwy. VV to end of North Bend Drive.

Operation of an all-terrain vehicle on a roadway which is an all-terrain vehicle route is authorized only for the extreme right side of the roadway except that left turns may be made from any part of the roadway which is safe given prevailing conditions.

SECTION FOUR: PENALTY. Those penalties set forth in section 23.33(13) of the Wisconsin Statutes are expressly incorporated herein by reference and made a part

hereof.

SECTION FIVE: SEVERABILITY. If any section of this ordinance is found to be unconstitutional or otherwise invalid, the validity of the remaining sections shall not be affected.

SECTION SIX: CONFLICTING ORDINANCES. Ordinances or part of ordinances in conflict with the above ordinance are hereby repealed.

SECTION SEVEN: EFFECTIVE DATE. Upon passage of and posting, this ordinance shall take effect and be in force as provided by law.

SECTION EIGHT: NOTICES. The clerk shall immediately send a copy of this ordinance to the Department of Natural Resources and to the Jackson County Sheriffs Department and/or any other law enforcement agency of the municipality or county having jurisdiction over any highway designated as an all-terrain vehicle route.
