Statutes, specifically a proposed tax levy which would exceed the allowable town tax levy for 2019 by 24.91 percent which would be a dollar increase of \$20,000;
2. To approve the 2019 total town tax levy to be collected in 2020 pursuant to s. 60.10(1)(a) of Wis. Statutes.
